Bridge* Vacation

The Pleasant Township Trustees have requested that a bridge be Vacated per O.R.C. 5553.04-5553.11. I submit the following:

TR138 in Pleasant Township was established in the 1880's. The road served the 'public good' until 1947 when a portion of the roadway between CR37 and the now abandoned Cleveland, Cincinnati, Chicago & St Louis Railroad was vacated.

It is important to note that because the Railroad was established prior to the establishment of TR138, the road right of way ended at, and began again at the 100-foot limit of the railroad property. Basically, there is a gap in the road right of way at nearly every railroad crossing in Seneca County.

Because there was an open ditch along the east side of the railroad for drainage purposes, it was necessary for a bridge to be built for roadway continuity. Said bridge was constructed on railroad property over the ditch sometime in the late 1800's, and exists today as a farm field crossing.

As I see it, the following are the facts of this matter:

- 1. The bridge was constructed on railroad property and never resided on Township right of way.
- 2. The bridge was constructed and maintained by Seneca County (Pleasant Township) until the adjacent roadway was vacated.
- 3. When the roadway was vacated, the bridge was technically not vacated because it never existed on township right of way.
- 4. The land once occupied by the railroad is now in private ownership, therefore the bridge now exists on private property.
- 5. There is no precedent that I know of in Seneca County to address the actual ownership and responsibility of said bridge.

Therefore, out of an abundance of caution and to relieve the County/Township of any maintenance responsibility, I suggest the bridge be vacated and ownership passed to the underlying property owners. It is my opinion that the bridge is in 'ownership limbo' and that it is not necessarily recognized that the structure is even currently owned by the County/Township. I consider this vacation to act as a Quit Claim of the structure, and setting no precedent of ownership for other potential orphaned or abandoned infrastructure in Seneca County.

This vacation will simply serve to vacate any interest, if it exists, to this structure.

I believe it to be in the public interest to set a viewing/hearing for this vacation at your earliest convenience.
